2. You must keep your sale items within your assigned booth space.
3. You can purchase no more than 2 spaces.
4. You must indicate if you want to sell from your trunk on hard top or have a 10x10 space in the grass.
5. Booth assignments are on a first come, first served basis.
6. You provide any tents, tables, and chairs.
7. We will **email** your booth #, location, and map by Monday, April 13th.
8. The Town of Kilmarnock has the right to refuse space to any vendor who does not comply with these rules. The Great Find Organizers, or their designee, shall be sole judges as to the suitability of a vendor's merchandise.
9. There will be NO REFUNDS. No rain date.

7. Only one vendor per booth. You cannot share with someone selling items that are not yours.
8. You cannot change spots with any other vendors after assigned.

11. You will not be able to set-up the night before.
