## **ORDINANCE 2026 – 006 (uncodified)**

### **ADOPT, RE-ADOPT CERTAIN UTILITY RATES**

**WHEREAS**, the Town Council desires to re-adopt utility rates for water for the 2026-27 fiscal year, which are the same rates as last fiscal year without change; and

**WHEREAS**, the Town Council also desires to repeal prior sewer utility rates and to adopt new utility rates for sewer, for the 2026-27 fiscal year, which represent an increase over last fiscal year of \$5.00 per month in the base amount for in-town residential and commercial customers, and an increase over last fiscal year of \$7.50 per month in the base amount for out-of-town residential and commercial customers; and

**WHEREAS**, this Ordinance and notice of public hearing were advertised in the Rappahannock Record on May 28, 2026 and June 4, 2026 pursuant to VA Code §15.2-2506 and VA Code §15.2-107; and

**WHEREAS**, a public hearing on the utility rates and a first reading of this Ordinance were held on June 15, 2026; and

**WHEREAS**, notice of adoption and re-adoption of certain utility rates was advertised in the Rappahannock Record on May 28 and June 4, 2026; and

**WHEREAS**, a final reading of this Ordinance 2026-006 was held on June 22, 2026, as well as discussion by Council members of the basis for the increase in sewer utility fees..

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF KILMARNOCK, VIRGINIA** that this Ordinance 2026-006, together with the document entitled “Town of Kilmarnock Utility Rates In-Town (Bimonthly) Effective July 1, 2026” and “Town of Kilmarnock Utility Rates Out-of-Town (Bimonthly) Effective July 1, 2026”, attached hereto, and incorporated herein by this reference, is hereby adopted with effect from July 1, 2026.
